



Privacy Policy - Sandy Kriss Interior

A. Introduction

The privacy of visitors to our Facebook page is very important to us, and we are committed to protecting it. This policy explains what we do with your personal information.

Consenting to our use of cookies in accordance with this policy during your first visit to our website allows us to use cookies each time you visit our site.

C. Collection of Personal Information

We may collect, store, and use the following types of personal information:

- Information about your computer, including your IP address, geographical location, browser type and version, and operating system;
- Information about your visits to and use of this website, including the referral source, length of visit, page views, and website navigation paths;
- Information such as your email address that you provide when you register on the site;
- Information you enter when creating a profile on our website, such as your name, profile picture, gender, date of birth, relationship status, interests and hobbies, educational and professional background;
- Information such as your name and email address that you enter to subscribe to our emails and/or newsletters;
- Information that you enter when using the services on our website;
- Information generated while using our website, including when, how often, and under what circumstances you use it;
- Information relating to any purchases you make, services you use, or transactions you carry out through our website, including your name, address, telephone number, email address, and banking information;
- Information that you post on our website with the intention of publishing it online, including your username, profile photos, and the content of your posts;
- Information contained in any communication you send to us by email or through our website, including its content and metadata;
- Any other personal information you choose to send us.

Before you disclose personal information about another person, you must obtain that person's consent for both the disclosure and the processing of their personal information in accordance with this policy.

D. Use of Your Personal Information

Personal information submitted to us through our website will be used for the purposes specified in this policy or on the relevant pages of the website. We may use your personal information to:

- Administer our website and business;
- Personalise our website for you;
- Enable your use of the services available on our website;
- Send you goods purchased on our website;
- Supply services purchased through our website;
- Send you statements, invoices, and payment reminders, and collect payments from you;
- Send you non-marketing commercial communications;
- Send you email notifications you have specifically requested;
- Send you our newsletter by email, if you have requested it (you may inform us at any time if you no longer wish to receive the newsletter);
- Send you marketing communications relating to our business or carefully selected third-party businesses that we believe may interest you, by post or — if you have expressly agreed — by email or similar technology (you may inform us at any time if you no longer wish to receive marketing communications);
- Provide third parties with statistical information about our users (third parties will not be able to identify any individual user from this information);
- Handle enquiries and complaints made by or about you relating to our website;
- Keep our website secure and prevent fraud;
- Verify compliance with the terms and conditions governing the use of our website (including monitoring private messages sent through our website's private messaging service);
- Other uses.

If you submit personal information for publication on our website, we will publish and otherwise use that information in accordance with the permissions you grant us.

Your privacy settings can be used to limit the publication of your information on our website and can be adjusted through your privacy controls on the site.

Without your explicit consent, we will not supply your personal information to any third party for their direct marketing or that of any other third party.

E. Disclosure of Your Personal Information

We may disclose your personal information to any of our employees, officers, insurers, professional advisers, agents, suppliers, or subcontractors when reasonably necessary for the purposes set out in this policy.

We may disclose your personal information to any member of our corporate group (this means

our subsidiaries, our ultimate holding company, and all its subsidiaries) when reasonably necessary for the purposes set out in this policy.

We may disclose your personal information:

- To the extent required by law;
- In connection with any ongoing or prospective legal proceedings;
- To establish, exercise, or defend our legal rights (including providing information to others for fraud prevention and credit risk reduction);
- To the purchaser (or potential purchaser) of any business or asset that we are selling (or considering selling);
- To any person whom we reasonably believe may apply to a court or other competent authority for the disclosure of that personal information if, in our reasonable opinion, such court or authority would be likely to order disclosure.

Except as provided in this policy, we will not provide your personal information to third parties.

F. International Data Transfers

Information we collect may be stored, processed, and transferred between any of the countries in which we operate, to allow us to use the information in accordance with this policy.

Information we collect may be transferred to the following countries, which do not have data protection laws equivalent to those in the European Economic Area: the United States of America, Russia, Japan, China, and India.

Personal information you publish on our website or submit for publication may be available worldwide via the internet. We cannot prevent the use or misuse of such information by others. You expressly agree to the transfers of personal information described in this Section F.

G. Retaining Personal Information

This Section G sets out our data retention policies and procedures, designed to help ensure our compliance with legal obligations regarding the retention and deletion of personal information.

Personal information that we process for any purpose will not be kept longer than necessary for that purpose or those purposes.

Without prejudice to Section G-2, we will usually delete personal data of the categories below at the date and time set out here:

These types of personal data will be deleted after 30 days and 60 days.

Notwithstanding the other provisions of this Section G, we will retain documents (including electronic documents) containing personal data:

- To the extent required by law;
- If we believe the documents may be relevant to any ongoing or future legal proceedings;
- To establish, exercise, or defend our legal rights (including providing information to others for fraud prevention and credit risk reduction).

H. Security of Your Personal Information

We will take reasonable technical and organisational precautions to prevent the loss, misuse, or alteration of your personal information.

We will store all the personal information you provide on secure servers (password- and firewall-protected).

All electronic financial transactions conducted through our website will be protected by encryption technologies.

You acknowledge that the transmission of information over the internet is inherently insecure, and we cannot guarantee the security of data sent over the internet.

You are responsible for keeping the password you use to access our website confidential; we will never ask you for your password (except when logging in).

I. Amendments

We may update this policy from time to time by publishing a new version on our website. You should check this page regularly to ensure you understand any changes to this policy. We may notify you of changes to this policy by email or through the private messaging service on our website.

J. Your Rights

You may request that we provide you with any personal information we hold about you.

We may withhold personal information you request to the extent permitted by law.

You may instruct us at any time not to process your personal information for marketing purposes.

In practice, you will generally either expressly agree in advance to our use of your personal information for marketing purposes, or we will provide you with an option to opt out of marketing.

K. Third-Party Websites

Our website contains hyperlinks to, and details of, third-party websites. We have no control over these websites and are not responsible for their privacy policies or practices.

L. Updating Information

Please let us know if the personal information we hold about you needs to be corrected or updated.

M. Cookies

Our website uses cookies. A cookie is a file containing an identifier (a string of letters and numbers) sent by a web server to a web browser and stored by the browser. The identifier is

then sent back to the server whenever the browser requests a page from the server.

Cookies may be “persistent” or “session” cookies:

- A persistent cookie is stored by the browser and remains valid until its expiration date unless deleted by the user before that date;
- A session cookie expires at the end of the user session, when the browser is closed.

Cookies generally do not contain information that personally identifies a user, but personal information that we store about you may be linked to the information stored in and obtained from cookies.

We only use session cookies on our website.
